



HDX to Acquire Biz-Pro Ltd.

Toronto, Ontario – Nov 20, 2007 - Hosted Data Transaction Solutions Inc. (“HDX”) announced today that it has signed a letter of intent to acquire Biz-Pro Ltd. (“Biz-Pro”) for \$3,000,000 subject to closing adjustments. The purchase price will be satisfied by the payment of \$2,000,000 in cash and by the issuance of 1,000,000 HDX common shares, which will be subject to a 36 month hold period. The cash portion of the transaction shall be satisfied with cash that HDX has available in its treasury. No financing is required for this transaction and the parties to the transaction are at arms length.

HDX (formerly Dexit Inc.) is listed on the TSX under the symbol HDX.

Biz-Pro, established in 1975, is a profitable London based point-of-sale technology company with annual revenue of approximately \$3.2 Million. HDX recently announced the acquisition of Howell Data Systems QSR and Sabrepoint Inc. The historical annual revenue of these companies combined with Biz-Pro Ltd. is approximately \$10 million.

Specializing in solutions for the hospitality industry, Biz-Pro has fourteen employees and has deployed over twenty thousand systems across Canada. Biz-Pro provides services to thousands of customers including Compass Group Canada, Sodexho, Brown’s Fine Foods, Mary Brown’s Fried Chicken, and Lewisfoods.

“The agreement with Biz-Pro is a tremendous step forward in our goal of building a very significant organization dedicated to providing business control systems, business intelligence tools and consumer payment systems,” says Paul Howell, president and CEO of HDX. “Jim and Kathy Jearvis have built an amazing company and many Biz-Pro team members have over fifteen years of experience. Biz-Pro has been a leader in the Canadian point of sale industry for over thirty years and our corporate philosophies towards providing quality products and excellent customer service are closely aligned.

“These are exciting times for the Biz-Pro team,” says Jim Jearvis, President of Biz-Pro. “The added features and benefits of the HDX product line will enhance our sales efforts and give us an opportunity to better serve our customer base. The larger combined company provides the extra team resources required to develop advanced technology and the ability to service customers in a wide geographic area.”

Jim Jearvis and Chris Jearvis, VP of Operations will manage the day to day operation of the Biz-Pro organization moving forward.

The transaction is expected to close on Jan 1st 2008 and is subject to completion of due diligence by HDX, customary closing conditions, receipt of all necessary regulatory approvals and the negotiation and execution of a definitive purchase and sale agreement.
